⁴⁾ No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

⁵⁾ Where several documents are issued together to the citizen, a total fee of DKK 195 shall be charged.

⁶⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 195 shall be charged per statement.

⁷⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,150 shall be charged for the first passport and DKK 955 for subsequent passports.

⁸⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,075 shall be charged for the first passport and DKK 955 for subsequent passports.
