<sup>3)</sup> NB: A fee of EUR 35 (DKK 260/IDR 650,000) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

<sup>4)</sup> No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

<sup>5)</sup> Where several documents are issued together to the citizen, a total fee of IDR 650,000 / DKK 260 shall be charged.

<sup>6)</sup> Provided the request for VAT refund comprises several separate purchases, a fee of IDR 512,500 / DKK 205 shall be charged per statement.

<sup>7)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of IDR 6,025,000 / DKK 2,410 shall be charged for the first passport and IDR 4,450,000 / DKK 1,780 for subsequent passports.

<sup>8)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of IDR 8,612,500 / DKK 3,445 shall be charged for the first passport and IDR 4,450,000 / DKK 1,780 for subsequent passports.
