<sup>2)</sup> If case processing is required, an hourly rate or part thereof shall be charged.

<sup>3)</sup> NB: A fee of EUR 35 (DKK 260/IDR 520,000) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

<sup>4)</sup> Where several documents are issued together to the citizen, a total fee of IDR 570,000 / DKK 285 shall be charged.

<sup>5)</sup> Provided the request for VAT refund comprises several separate purchases, a fee of IDR 450,000 / DKK 225 shall be charged per statement.

<sup>6)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of IDR 5,280,000 / DKK 2,640 shall be charged for the first passport and IDR 2,260,000 or IDR 3,564,000 / DKK1,130 or DKK 1,782 for subsequent passports.

<sup>7)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of IDR 7,540,000 /DKK 3,770 shall be charged for the first passport and IDR 2,260,000 or IDR 3,564,000 / DKK1,130 or DKK 1,782 for subsequent passports.
