³) NB: A fee of EUR 35 (DKK 260/IDR 652,000) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

⁴) Where several documents are issued together to the citizen, a total fee of IDR 712,000 / DKK 285 shall be charged.

⁵) Provided the request for VAT refund comprises several separate purchases, a fee of IDR 562,500 / DKK 225 shall be charged per statement.

⁶) Where several provisional passports or extension of passports are issued at the same time, a fee of IDR 6,600,000 / DKK 2,640 shall be charged for the first passport and IDR 2,825,000 or IDR 4,455,000 / DKK1,130 or DKK 1,782 for subsequent passports.

⁷) Where several provisional passports or extension of passports are issued at the same time, a fee of IDR 9,425,000 /DKK 3,770 shall be charged for the first passport and IDR 2,825,000 or IDR 4,455,000 / DKK1,130 or DKK 1,782 for subsequent passports.
