³) NB: A fee of EUR 35 (DKK 260) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

⁴) No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

⁵) Where several documents are issued together to the citizen, a total fee of IDR 400,000 / DKK 200 shall be charged.

⁶) Provided the request for VAT refund comprises several separate purchases, a fee of IDR 400,000 / DKK 200 shall be charged per statement.

⁷) Where several provisional passports or extension of passports are issued at the same time, a fee of IDR 4,530,000 / DKK 2,265 shall be charged for the first passport and IDR 1,940,00 / DKK 970 for subsequent passports.

⁸) Where several provisional passports or extension of passports are issued at the same time, a fee of IDR 6,480,000 /DKK 3,240 shall be charged for the first passport and IDR 1,940,00 / DKK 970 for subsequent passports.
